WHEREAS, the study indicates a need for a stop sign for northbound and southbound traffic on newly graded 190th Avenue (P-60 near LuVerne) at the intersection of Garfield Street and 190th Avenue, for northbound traffic on 190th Avenue and at the intersection of 190th Avenue and 100th Street (C-12) for southbound traffic on 190th Avenue on the west line of Section 31, T-94N, R-27W, LuVerne Township.

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors:

That a stop sign be installed for northbound and southbound traffic on newly graded 190th Avenue (P-60 near LuVerne) at the intersection of Garfield Street and 190th Avenue, for northbound traffic on 190th Avenue and at the intersection of 190th Avenue and 100th Street (C-12) for southbound traffic on 190th Avenue on the west line of Section 31, T-94N, R-27W, Lu Verne Township.
