Motion by McGregor and 2nd by Elsbecker that the Board of Supervisors of Kossuth County, Iowa does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to remove existing overhead line and install underground primary cable. Work will involve removing overhead line and boring under 480th Street, approximately 1,500 feet east of 50th Avenue. The work will be in the north and south right of way of 501 480th Street, Section 23 and 26 Eagle Township. Permit number 08-26-2012 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Elsbecker and 2nd by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to remove existing overhead line and install underground primary cable. Work will involve removing overhead line and boring under 30th Avenue, approximately 850 feet north of 370th Street. The work will be in the east and west right of way of 3701 30th Avenue, Section 16 and 17 Seneca Township. Permit number 08-27-2012 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by McGregor and 2nd by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to remove existing overhead line and install underground primary cable. Work will involve removing overhead line and boring under 450th Street, approximately 750 feet east of 20th Avenue. The work will be in the north and south right of way of 202 450th Street, Section 8 and 5 Swea Township. Permit number 08-28-2012 is on file in the Kossuth County Engineer's Office. Motion carried.

Discussion with Kossuth County Engineer was held followed by drainage, discussion with Kossuth County Auditor and Board Discussion and Committee Reports.

On motion adjournment was taken until August 7 , 2012.
