Motion by Plathe and 2nd by Besch to approve the minutes as read. Ayes all, Nays none. Motion carried unanimous.

Motion by Elsbecker and 2nd by McGregor to approve the agenda, with the omission of tour of Whittemore Township as problem solved. Ayes all, Nays none. Motion carried unanimous.

Public discussion and committee reports were held.

Motion by McGregor and 2nd by Elsbecker to table the 28E agreement with Central Iowa Juvenile Detention Center until they get back to us. Ayes all, Nays none. Motion carried unanimous.

Motion by McGregor and 2nd by Plathe to table the liquor permit for Whittemore Golf Course until next week. Ayes all, Nays none. Motion carried unanimous.

Motion by McGregor and 2nd by Besch to approve as Delegate, Tom Johnson and Alternate, David Newbrough to the North Central Iowa EMS Board. Ayes all, Nays none. Motion carried unanimous.

Motion by McGregor and 2nd by Elsbecker to approve new car bid from Elbert Chevrolet, Inc. for a 2006 Chevrolet 1LG26-Equinox AWD LS for \$20,500 to be used in the Sheriff's Department. Bids were submitted by Kemna Auto Center and Karl Chevrolet, Inc. Ayes all, Nays none. Motion carried unanimous.

Motion by McGregor and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Interstate Power and Light Company, Mason City, IA, to install new poles, anchors down guys and overhead conductors. Work will begin at the intersection of 90th Avenue/280 Street going east 1.25 mile, then south 1 mile of the east side of 100th Avenue. Then continuing from Highway 169 to 280th Street. Work will be in Sections 33, 34 and 35 Burt Township and Section 3 Union Township. Permit number 06-10-41 is on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.

Motion by Plathe and 2nd by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Corn Belt Power Cooperative, Humboldt, IA, to construct 6.55 miles of new overhead transmission line. Work will begin at the Whittemore Substation Section 15 Whittemore Township going east 3 miles, north 1 mile and east .55 mile ending at the Hobarton Substation, Section 4 Cresco Township. Permit number 06-10-40 is on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.

Resolution # 10-02-06-01

Moved by Elsbecker and seconded by Froehlich to approve the following resolution:

WHEREAS, Section 306.41 of the Code of Iowa provides for the temporary closing of sections of roadway when necessary because of construction, and

WHEREAS, the County Engineer has been authorized by a previous resolution of this Board of Supervisors to execute the requirements of Section 306.41 regarding temporary road closures, and

WHEREAS, a culvert replacement project L-C571470--73-55 will require that 200th Street from 230th Avenue east to R-14 be closed to all traffic, and

WHEREAS, a culvert replacement project L-C671206--73-55 will require that R-14 from 260th Street to 270th Street be closed to all traffic, and

WHEREAS, a culvert replacement project L-C671301--73-55 will require that R-14 from 250th Street to 260th Street be closed to all traffic, and

WHEREAS, a culvert maintenance project will require that 110th Street from U.S. Highway 169 to 130th Avenue be closed to all traffic, and

WHEREAS, a culvert maintenance project will require that 170th Street from 50th Avenue to 60th Avenue be closed to all traffic, and

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that the above described roads be closed and proper signs be erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED, that upon completion of the construction work, as determined by the County Engineer, the roads shall be opened to the traveling public without further action of this board.
