Motion by Wymore and 2<sup>nd</sup> by Elsbecker that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Telecommunications, Emmetsburg, IA, to replace cable due to a road project. Work will involve replacing 780' of 25 pair cable in the north right way of 390<sup>th</sup> Street, Section 2, Seneca Township. Permit number 09-10-27 is on file in the Kossuth County Engineer's Office. Ayes: all Nays: none Motion carried unanimous.

Motion by McGregor and 2<sup>nd</sup> by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Allen Kramer, Algona, IA, to install a new 18" diameter dual wall plastic tile under 100<sup>th</sup> Avenue. The new tile will be installed by cutting the gravel road approximately 4,750 feet north of the intersection of 180<sup>th</sup> Street and 100<sup>th</sup> Avenue, between Section 21 and 22, Cresco Township. Permit number 09-10-29 is on file in the Kossuth County Engineer's Office. Ayes: all Nays: none Motion carried unanimous.

Motion by Besch and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Phillip Bernhard, Bancroft, IA, to install a new 12" diameter dual wall plastic tile under 330<sup>th</sup> Street. The new tile will be installed by cutting the gravel road approximately 2,940 feet west of the intersection of US Highway 15 and 330<sup>th</sup> Avenue, between Section 6 and 7, Fenton Township. Permit number 09-10-28 is on file in the Kossuth County Engineer's Office. Ayes: all Nays: none Motion carried unanimous.
