Public discussion and Committee Reports were held.

Motion by Plathe and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Gary Erpelding, Algona, IA, to install new 18" diameter drain tile under 160<sup>th</sup> Avenue. Work will involve boring approximately 400 feet south of the intersection of Highway 18 and P56 (160<sup>th</sup> Avenue) between Section 3 and Section 4 of Irvington Township. Permit number 11-09-20 is on file in the Kossuth County Engineer's Office. Motion carried.

Discussion in regards to the City of Algona Police Department being relocated to the Kossuth Co LEC continued with the Board and Steve Kollasch, Paul Gronbach and Ron Reefer.

Mike Brennan, City Administrator of the City of Bancroft was present to discuss with the Board of Supervisors plans for a portion of North Kossuth Golf Club to be annexed into the City of Bancroft. The City Council is having a public hearing on October 10, 2011.

Motion by Besch and 2<sup>nd</sup> by Elsbecker to approve the applications for exemption from buffer strip ban in drainage district facilities.

Don McGregor updated the Board of Supervisors on the progress the Redistricting Commission is making in completing the process of redistricting and reprecincting.

On motion adjournment was taken until September 27, 2011.
