The Board of Supervisors acknowledged the Wellness Minutes for September 7, 2016.

The Board of Supervisors acknowledged transfers made by Kossuth County Auditor, Amber Garman on September 6, 2016 from the General Basic Fund to the Secondary Road Fund in the amount of \$10,709.88 and from the Rural Basic Fund to the Secondary Road Fund in the amount of \$20,041.21.

Motion by Tjarks and 2<sup>nd</sup> by Plathe to approve Applications for Exemption from Buffer Strip Ban in Drainage District Facilities. Motion carried.

Motion by Wymore and 2<sup>nd</sup> by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Midland Power Cooperative, Jefferson, IA, to replace power poles, remove an overhead power line and bury in conduit a single phase electric line. Work will begin 170 feet east of intersection of 160<sup>th</sup> Avenue on 250<sup>th</sup> Street, then boring northwest to a power pole 150 feet north of intersection, between Sections 15 & 22 Plum Creek Township. Permit number 09-26-2016 is on file in the Kossuth County Engineer's Office. Motion carried.

Discussion with Kossuth County Auditor was held followed by Board Discussion and Committee Reports.

On motion adjournment was taken until September 27, 2016.
