Motion by Besch and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Interstate Power & Light, Britt, IA, to trench the right of way at the intersection of 240<sup>th</sup> Avenue and 240<sup>th</sup> Street to install underground and remove overhead electric. Work will be between Sections 23 and 26, Wesley Township. Permit number 09-29-2017 is on file in the Kossuth County Engineer's Office. Motion carried.

Discussion was held with Kossuth County Engineer/Kossuth County Zoning Administrator followed by drainage, discussion with Kossuth County Auditor and Board Discussion and Committee Reports.
