REGULAR APRIL SESSION

Public discussion was held followed by discussion with Secondary Road Foreman.

Resolution #04-24-18-01

WHEREAS, Section 459.202 of the Code of Iowa provides separation distances for Confinement Feeding Operations, and

WHEREAS, Section 459.202 of the Code of Iowa specifies that a confinement feeding operation structure shall not be constructed or expanded within one hundred feet from a public thoroughfare, and

WHEREAS, Section 459.205 of the Code of Iowa provides exemptions to separation distances for Confinement Feeding Operations, and

WHEREAS, Section 459.205 of the Code of Iowa of Iowa allows political subdivisions to execute written waivers to separation distances with the owners of Confinement Feeding Operations, and

WHEREAS, Banwart Dairy Inc., 108 110th Street, West Bend, IA 50597 requests a waiver to the separation distance between a proposed dairy confinement operation and 110th street in the NW ¼ of the NE ¼ of Section 31, Garfield Township be reduced to 50 feet, and

NOW, THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors to execute a written waiver to Banwart Dairy Inc. that reduces the separation distance as requested above.
