## A RESOLUTION APPROVING AN APPLICATION FOR WECS CONSTRUCTION PERMIT BY EDF RENEWABLES DEVELOPMENT, INC.

## Kossuth County Board of Supervisors Resolution No. 12-11-18-02

WHEREAS, Kossuth County has heretofore enacted Ordinance #310-A – "An Ordinance Regulating, the Construction and Operation of Commercial Wind Energy Conversion Systems (WECS) in Kossuth County, Iowa (the "Ordinance"), and

WHEREAS, EDF Renewables Development, Inc. ("EDF") has, pursuant to the Ordinance, filed and Application for a WECS Permit to construct and operate a WECS in Kossuth County to be called Golden Plains Wind Farm (the "Project"), and

WHEREAS, the Application has been reviewed by the Zoning Administrator and found to be in conformity with the requirements of the Ordinance, and

WHEREAS, notice of the filing of the Application was mailed and published in accordance with the Ordinance, and

WHEREAS, notice of a public hearing on the Application was mailed and published in accordance with the Ordinance, and

WHEREAS, a public hearing was held by the Board of Supervisors on December 4<sup>th</sup>, 2018, per the requirements of Iowa Law and the Ordinance, and

WHEREAS, following the public hearing, EDF submitted a Final Development Plan ("FDP") to the Zoning Administrator showing the final location of all turbines and other components comprising the Project, and

WHEREAS, the Kossuth County Board of Supervisors has considered the public comments, and, having reviewed the Application and the FDP, FINDS that the Application and the FDP are complete and in compliance with the terms of the Ordinance, that all notice requirements pertaining to the Application and the public hearing were compiled with in accordance with the Ordinance and Iowa law, and that all other requirements under the Ordinance for issuance of a WECS Construction Permit have been satisfied, and

WHEREAS, the Kossuth County Board of Supervisors concludes that a WECS Construction Permit for the Project should be granted.

County Zoning Administrator is hereby directed to issue a WECS Construction Permit to EDF for the construction and operation of the Project.
