

BOARD PROCEEDINGS
November 24, 2020
REGULAR NOVEMBER SESSION

The Board of Supervisors met pursuant to adjournment. Present were: Jack Plathe, Chairman, Roger Tjarks, Donnie Loss, Kyle Stecker and Galen Casey.

Chairman Plathe called the meeting to order at 8:00 a.m. followed by the Pledge of Allegiance.

Public discussion was held and the Board of Supervisors reviewed the handwritten claim.

Work will be in Section 30 of Wesley Township. Permit number 11-44-2020 is on file in the Kossuth County Engineer's Office and that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Interstate Power and Light, Britt, IA, to remove overhead pole transformer and service at 1903 230th Street. Work will be in Section 30-31 of Wesley Township. Permit number 11-45-2020 is on file in the Kossuth County Engineer's Office.
