Motion by Tjarks and 2nd by Stecker to Approve abandonment of District Main through the USFWS property, abandonment of Lateral No. 3 and 3A with blocking and crushing the tile east of 145th Ave.,

open ditch from outlet to 330th Street, full tile main replacement above 330th Street with 0.75" drainage coefficient, direct engineer to proceed permitting with USACE and IDNR, and direct engineer to proceed with final plans and specification for sealed bidding of improvements. Chairman Tjarks called for a roll call: Stecker: yes, Casey: yes, Loss: yes, Plathe: yes, Tjarks: yes. Motion carried.

Motion by Stecker and 2nd by Casey to approve Involuntary annexation of additionally benefitted lands with resolution of necessity, direct engineer to proceed with ROW acquisition for open ditch and appointment of appraisers, and order reclassification of DD75 with separation of schedules for open ditch, main tile and lateral tiles and appointment of commissioners. Motion carried unanimously.

Motion by Tjarks and 2nd by Casey to approve full tile main replacement of Lateral 1 with 0.75" drainage coefficient, and direct engineer to proceed with final plans and specification for sealed bidding of improvements. Chairman Tjarks called for a roll call: Stecker: yes, Casey: yes, Loss: yes, Plathe: yes, Tjarks: yes. Motion carried.

Motion by Tjarks and 2nd by Loss to direct engineer to proceed with Lateral 4 & 5. Motion carried unanimously.
