A monthly update was given by the Veteran's Affairs Director, Dan Green.

Motion by Stecker and 2<sup>nd</sup> by Waechter to direct the county engineer and county attorney to look into classifying 165<sup>th</sup> Ave. between 250<sup>th</sup> Street and 260<sup>th</sup> Street as a Class C Road per Iowa Code 309.57. Chairman Tjarks called for a roll call vote: Plathe: yes, Nath: yes, Waechter: yes, Stecker: yes, Tjarks: yes. Motion carried.

The board of supervisors acknowledged the transfers made by Kossuth County Auditor Tammy Eden in the amount of \$2,519.39 from General Basic to Secondary Road and \$19,055.11 from Rural Basic to Secondary Road. The transfers were made on July 5, 2023.

Motion by Stecker and 2<sup>nd</sup> by Waechter to abate the taxes on 205 Dewitt Street, LuVerne Iowa. Supervisor Nath Abstained. All other supervisors voted aye. Motion carried.

A discussion was held regarding the Kossuth County Engineer's Contract. This item will be put back on the agenda on August 8, 2023 for possible changes to be made to the contact.

Motion by Tjarks and 2<sup>nd</sup> by Stecker to authorize and give its permission to Interstate Power & Light, Britt, IA to: extend overhead electric in the north right of way from 1003 280<sup>th</sup> Street, 250 feet east then plow underground another 800 feet east. Work will be in Section 34, Burt Township, Kossuth County. Permit 07-20-2023 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Motion by Tjarks and 2<sup>nd</sup> by Waechter to authorize and give its permission to Midland Power Cooperative, Jefferson, IA to: replace overhead electric with underground electric at 3107 180<sup>th</sup> Avenue by boring under road approximately 1140 feet south of 320<sup>th</sup> Street. Work will be in Sections 13 & 14 of Portland Township. Permit 07-21-2023 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Discussion was held with the Kossuth County Engineer/Zoning Administrator.

Motion by Waechter and 2<sup>nd</sup> by Plathe to have the supervisors handle their requests as follows: Supervisor Stecker: Request 2023-071 DD 135; Request 2023-072 DD 82; Request 2023-073 DD 152; Request 2023-074 DD 2; Request 2023-076 DD 125; Supervisor Tjarks: Request 2023-075 DD 78; Request 2023-077 DD 82. Motion carried unanimously.

Discussion was held with the Kossuth County Auditor and Kossuth County Board of Supervisors.

Motion by Stecker and 2<sup>nd</sup> by Nath to adjourn at 9:34 A.M. Motion carried unanimously.
