Whereas on February 20, 2024 the Kossuth County Board of Supervisors adopted the following Resolution – Adoption and Implementation of Wage Scale Changes

Whereas the Kossuth County Board of Supervisors has determined restructure of its wage scales for non-bargaining unit employees is in the public's interest to attract and retain qualified employees,

Be it resolved that

Kossuth County will implement the following wage schedule for any new employees hired on or after July 1, 2024. Current employees shall be moved to the following wage schedule on July 1, 2024 and will increase annually on July 1 of every year.

#### Stand-Alone Longevity Schedule for all Full Time Employees as follows:

.02 cents/hour per year of service with the cap at 20 years

#### Scale 1: Clerks/Support Staff in the Recorder, Treasurer, Attorney and Auditor's office

\$40,800.00/year Starting Wage \$45,900.00/year at 6 months probationary \$49,570.50/year at 1 year

## Scale 2: Custodians

\$22.95/hour Starting Wage \$24.48/hour 6 months probationary \$26.50/hour at 1 year

## Scale 3: Clerk/Driver's License Department

\$45,900.00/year Starting Wage \$51,000.00/year 6 months probationary \$55,585.19/year at 1 year

## Scale 4: Victim/Witness Coordinator

\$51,225.11/year Starting Wage \$52,249.61/year at 1 year

The board was provided copies of the transfers that were made from General Basic to Secondary Road in the amount of \$980.74 and from Rural Basic to Secondary Road in the amount of \$7,195.08. The transfers were made on February 5, 2024.

The board acknowledged Local Option Sales Tax (LOST) money transfers that were made from Rural Basic to Secondary Road in the amount of \$300,000.

Motion by Tjarks and 2nd by Waechter to authorize and give its permission to Interstate Power & Light of Spirit Lake, IA to rebuild and convert electric to 25kV operation by installing and replacing underground and replacing and removing overhead within the right of way. Work will be completed within the following right of way of: Fenton Township: 40th Ave between 300th St and 320th St, 50th Ave between 300th St and 310th St, 310th St between IA 15 and 70th Ave, and 300th St between 60th Ave and 70th Ave; Portland Township: 130th Ave. between 280th St and 310th St and 300th between 130th Ave and 140th Ave.; Burt Township: 70th Ave between 300th St and 320th St, 80th Ave between 290th St and 320th St, 100th Ave between 290th St and 300th St, 120th Ave between 290th St and 300th St, 310th St between 70th Ave and 80th Ave, 300th St between 70th Ave and 130th Ave.; Plum Creek Township: 130th Ave between 270th St and 280th St, 140th Ave between US 18 and 270th St and 270th St between 130th Ave and 140th Ave. Work will be in Sections 13-17 and 20-25 of Fenton Township; Sections 17-30 and 34-36 of Burt Township; Sections 19 and 31 of Portland Township; Sections 14 and 23 of Union Township; and Sections 6-8, 17-20 and 30-31 of Plum Creek Township. Permit number 02-02-2024 is on file in the Kossuth County Engineer's Office, see map attached to permit for installation details. Motion carried unanimously.
