Motion by Tjarks and 2nd by Plathe to approve the allows and disallows for the family farms applications. Motion carried unanimously.

Motion by Waechter and 2nd by Nath to approve the Ag Land allows and disallows. Motion carried unanimously.

Motion by Tjarks and 2nd by Waechter to authorize and give its permission to Midland Power Cooperative, Jefferson, IA to rebuild overhead electric in the north and south right of way of 190th Street between 170th Ave and 200th Ave. Work will be in Sections 25-26 and 35-36 Portland Township and Sections 30-31 Buffalo Township, Kossuth County. Permit Number 03-07-2024 on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Discussion was held with the Kossuth County Engineer/Zoning Administrator.

Motion by Nath and 2nd by Tjarks to authorize and give its permission to Andrew Struecker, IA, to install 104 feet of 24" ø Class III reinforced concrete pipe through 30th Avenue, 540 feet north of the southwest corner of Section 16, Whittemore Township, Kossuth County. Permit Number 03-06-2024 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Motion by Stecker and 2nd by Tjarks to approve the quote from B&W Control Specialists for drainage maintenance, once double checking is done on Lat 71. Motion carried unanimously.

Discussion was held regarding adding additional postcard mailings for landowner notifications in the internal drainage policy. Supervisor Stecker will make changes to the policy and present it to the board at next week's meeting.

Motion by Plathe and 2nd by Waechter to have the supervisors handle their requests as follows:
