Motion by Tjarks and 2nd by Nath to approve and sign the Avesis L3 Plan, which will be in effect until June 30, 2026. Motion carried unanimously.

Motion by Nath and 2nd by Waechter to approve and sign the Wellmark account information and binder agreement and set the Kossuth County Open Enrollment for May 2, 2024, through May 13, 2024. Motion carried unanimously.

The board acknowledged that Dona Nielsen will sign and send in the self-funded insurance final alternate rates and confirmation of MSP Addendum form and send the Cobra Addendum to Wellmark.

Kossuth County EMS Director Phil Albers gave a monthly update.

Motion by Tjarks and 2nd by Waechter to approve the pay increase for Mac Kahler to \$24.50/hour effective at the beginning of this pay period due to the advance of his certification to Paramedic. Motion carried unanimously.

Motion by Waechter and 2nd by Nath to approve ordering and locking in the bid for a 2026 Ambulance Chassis from Feld Fire in the amount of \$291,856 to be delivered in the Spring of 2026. Motion carried unanimously.

Motion by Stecker and 2nd by Waechter to approve the purchase of 1 re-certified transport ventilator with a one-year warranty in the amount of \$13,400 from Bound Tree and three Technimount Systems from Life Med Safety in the amount of \$18,000. Motion carried unanimously.

A discussion was held with EMS Director Phil Albers regarding approving a contract with KRHC for the transport of mental health patients. This will be addressed again at next week's board meeting.

Motion by Waechter and 2nd by Nath to approve the agreement with Language Line Solution for EMS. Motion carried unanimously.

An agreement with Credit Management Services, Inc for EMS collections was discussed. Phil Albers will talk to County Attorney Todd Holmes regarding collections, and it will be discussed at a later date, if needed.

Phil Albers, Kossuth County EMS Director requested the Kossuth County Handbook be updated to allow for EMS Personnel to receive 48 hours of vacation per year rather than 40 hours per year based on their work schedule. The handbook is currently under editing, and this will be addressed again before it is approved.

There was no construction in ROW.

Discussion was held with the County Engineer/Zoning Administrator.

Discussion was held with the Kossuth County Auditor and Board of Supervisors.
