Motion by Tjarks and 2nd by Waechter to authorize and give its permission to Algona Municipal Utilities, Algona, IA, to bore underground electric between 2215 Plum Creek Road and the north side of 230th Street and replace existing power pole and guy in the northeast corner of this intersection. Work will be in Section 30, Plum Creek Township. Permit 06-22-2024 is on file in the Kossuth County Engineer's Office. Motion carried unanimously.

Motion by Stecker and 2nd by Tjarks to amend the Fall 2024 Drainage District Assessments to what is in the current folder. Motion carried unanimously.
